#### Strategic Objectives and Work Plan for 2019-2020

#### **Discussion Paper**

### I. Purpose

This discussion paper proposes a set of strategic objectives and a work plan for the remaining period of the current GMI co-chairmanship term (2019-2020). The paper provides an overview of the three strategic objectives and related initiatives, milestones and expected results to be discussed during the November 2019 meeting (see Appendix A).

# II. Background

During its June 2017 meeting, the Steering Committee agreed GMI would benefit from defining a strategic direction on which to base its future efforts in a manner consistent with the new GMI charter and the Climate & Clean Air Coalition (CCAC)/United Nations Economic Commission for Europe (UNECE) alliance. A first set of Strategic Objectives was adopted for 2017-2018. Since then, the Steering Committee has presented updates on progress regarding the implementation of the strategic objectives during Steering Committee meetings. This practice has allowed the Steering Committee to gain in strategic focus and transparency.

#### III. Current Status

The proposed objectives build on the previous ones. Minor changes were made to objectives one and two, and a different third objective is proposed to address the upcoming re-chartering process of the GMI. The current Terms of Reference of the GMI are set to expire on 31 March 2021.

- 2. How can the GMI implement these priorities?
