#### **Background**

- Number of common partners:
  - GMI and CCAC have 24 country partners in common
  - GMI and UNECE have 15 partners in common
- Both CCAC and UNECE have methane-specific activities that align with or complement GMI activities:
  - CCAC: Three sector-focused initiatives (Ag, MSW, Oil & Gas), as well as cross-cutting initiatives (SNAPs, regional assessments, financing).
  - UNECE: Group of Experts on Coal Mine Methane (e.g., co-hosted GMI Coal Subcommittee, worked with GMI to identify Best Practices for CMM Drainage);
     Group of Experts on Oil & Gas.

### **Background (con't)**

- Task Force recommendations:
  - CCAC: Seek "non-state" partner status, more formally align GMI subcommittees with CCAC counterparts (where applicable).
  - UNECE: Align GMI coal mine sector work with the UNECE Group of Experts on Coal Mine Methane, explore a similar collaboration between GMI Oil & Gas Subcommittee and UNECE Sustainable Energy Division Group of Experts on Natural Gas.



### **Background (con't)**

- Task Force recommendations (con't):
  - World Bank: Continue to explore opportunities to align with World Bank's climate change group (e.g., Pilot Auction Facility for Methane and Climate Change, Global Gas Flaring Reduction Partnership).



#### **Actions Taken: CCAC**

- In 2015, GMI provided updates to CCAC Steering Committee and Working Group, which resulted in GMI reference in CCAC 5-year strategic plan and Global Methane Forum (GMF) co-organization.
- Ongoing collaboration at GMI sector/CCAC Initiative level (e.g., joint GMF meetings/ workshops) to share technical information and discuss plans for future collaboration and sharing of expertise.



### **Actions Taken: CCAC (con't)**

- Submitted letter seeking CCAC Non-State Partner status for GMI (approved in March), which allows GMI to send an official representative to CCAC Working Group meetings.
- Still need to decide whom to represent GMI at the CCAC meetings:
  - ASG staff
  - GMI Steering Committee designee
  - Rotating membership of the GMI Steering Committee.



#### **Actions Taken: UNECE**

- Continued successful ad-hoc coal mines sector collaboration (e.g., GMI Coal Subcommittee meetings with UNECE's Group of Experts on Coal Mine Methane, joint GMI/UNECE Best Practice Guidance for Effective Methane Drainage and Use in Coal Mines).
- GMI Oil & Gas Subcommittee joint meeting with UNECE – and CCAC – during GMF to discuss better sector collaboration.



# **Items for Steering Committee Consideration**

- How does the Steering Committee recommend that GMI should be represented at CCAC Working Group meetings?\*
- Would the Steering Committee like to request an update—prior to or at its next meeting—from the three GMI subcommittees (Biogas, Coal, and Oil & Gas) about the progress of collaboration with their counterparts in CCAC and UNECE?
