The Global Methane Initiative (GMI) is a voluntary, multilateral partnership that aims to reduce global methane emissions and to advance the abatement, recovery and use of methane as a valuable clean energy source.

The Initiative actively encourages participation from the private sector, governmental and non-governmental organizations, researchers, and development banks that have experience in methane abatement, recovery, and use in undertaking the following activities:

- Developing improved emission estimates and identifying the largest relevant emission sources to facilitate project development.
- Identifying cost-effective opportunities to recover methane emissions for energy production and potential financing mechanisms to encourage investment.
- Identifying and addressing barriers to project development and improving the legal, regulatory, financial, institutional, technological and other conditions necessary to attract investment in methane abatement, recovery, and utilization projects.
- Identifying and implementing collaborative projects aimed at addressing specific challenges to methane abatement or recovery.
